## FINAL NOTICE OF VOTE FOR LIARD FIRST NATION CONSTITUTION

Dear Liard First Nation Members:

Liard First Nation is holding a vote on the adoption of the proposed **Liard First Nation Constitution**. **The proposed Constitution must be approved by a vote of LFN Members by March 20, 2026**

The Information about the proposed Constitution was provided in the previous information package, January information sessions, and is available on the LFN website.

### VOTING INFORMATION

As indicated in previous notice, the vote will take place from **Monday, March 16, 2026 at 8:30 AM MST to Friday, March 20, 2026 at 4:30 MST**.

Voting will be conducted online via Simply Voting at this [webpage](#). You will only be able to log onto the platform starting on **March 16, 2026** at 8:30 am.

When clicking on the link you will be asked to provide the following information:

- your status number;
- your last name – you will need to spell your name exactly as it is written on your status card (with the correct punctuation – ex. If you have a “-” between two last names, or a space, make sure to write it as such); and
- your date of birth (YYYY/MM/DD).

Once you have populated the three fields, the webpage will open to the voting poll, and you will be asked to answer “yes” or “no” to the following question:

- **Do you approve the 2026 Liard First Nation Constitution?**

Once you have answered the question, you will click on the **CONTINUE** button and you will be asked to **CONFIRM** your vote. Once you have confirmed your vote, your vote will have been recorded. A **SUCCESS** message will pop up once confirmed.

**The results of the referendum will be released on March 21, 2026.**

If the majority of LFN Members voting, vote in favor of the proposed Constitution, it will be adopted and come into effect.

This is an opportunity for LFN to implement governance that represents the will and custom of the Nation, and to establish a harmonious and unified government to speak for all LFN members.
